3	PLAN MAP DESIGNATION AND NEIGHBORHOOD PLAN MAP DESIGNATION FOR
4	2425 STRONG ROAD SE, 3991 AND 3993 FAIRVIEW INDUSTRIAL DRIVE SE, AND 4080

6	The City of Salem ordains as follows:
7	Section 1. Findings. Pursuant to ORS 197.010(1), an amendment to the Salem Area
8	Comprehensive Plan Map must be approved by the City Council by ordinance. The Generalized
9	Land Use Map contained in the Morningside Neighborhood Association Neighborhood Plan was
10	adopted as a component of the Salem Area Comprehensive Plan pursuant to SRC 64.015(9). The
11	amendment to the Salem Area Comprehensive Plan Map is consistent with the criteria found in
12	Salem Revised Code (SRC) 64.025(e)(2) as set forth in "Exhibit 1," which is attached hereto and
13	incorporated herein by reference.
14	Section 2. 2425 Strong Road SE, 3991 and 3993 Fairview Industrial Drive SE, and 4080
15	Reed Road SE. The Salem Area Comprehensive Plan Map Designation, for an approximately
16	7.97-acre site consisting of four lots at 2425 Strong Road SE, 3991 and 3993 Fairview Industrial
17	Drive SE, and 4080 Reed Road SE, as identified in "Exhibit 2," is changed from "Industrial" to
18	"Industrial Commercial."
19	Section 2. Codification. In preparing this ordinance for publication and distribution, the City
20	Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but within such
21	limitations, may:
22	(a) Renumber sections and parts of sections of the ordinance;
23	(b) Rearrange sections;
24	(c) Change reference numbers to agree with renumbered chapters, sections or other parts;
25	(d) Delete references to repealed sections;
26	(e) Substitute the proper subsection, section or chapter, or other division numbers;
27	(f) Change capitalization and spelling for the purpose of uniformity;
28	(g) Add headings for purposes of grouping like sections together for ease of reference;
29	and
30	(h) Correct manifest clerical, grammatical or typographical errors.
