Subject: On-street parking and bus stops

I recently saw sandwich board signs on Winter Street between D Street and Market Street that read the City has received a request from Cherriots to eliminate on-street parking. There may be more locations in this proposal.

I emphatically say no. Winter Street is very wide and I frequently see driver's exceeding the speed limit. Removing cars only encourages this behaviour. The short amount of time that the buses are stopped to pick up or let off passengers is not long enough to be an inconvenience. And with the overly wide street, there's still room for cars to go around a stopped bus. They just need to slow down.

I find it odd that the City would have recently lowered speed limits around Grant Elementary and now wants to encourage people to drive fast. And because there are State offices on the south side of D Street and lots of pedestrians, cars should be slowed down as much as possible.

I also find it odd that Cherriots wants to continue the mindset that buses are in the way, don't belong and should yield as much space as possible to (single-passenger) vehicles.

Dear Mr. Dickey,

We own rental properties at 945 / 949 / 951 Winter and 921 / 923 / 925 Winter. We received the Bus Stop Improvement Notice and your letter, dated April 2, 2019. We are writing to you to let you know that we oppose the changes that are proposed to the bus stop in front of our properties. There are two main reasons for our objections: 1. Parking, and 2. Recycling Bins.

1. **Parking:** As I am sure you are aware, street parking in this area is very limited. We have between 11 to 14 tenants that live in our rental units. Although we have off-street parking in the alley, they depend on street parking to supplement the off-street parking.
2. **Recycling Bins:** There are 9 recycling, garbage and yard debris bins from our units that are placed on the street on Monday evening for Tuesday pick-up. The tenants return the bins to the properties usually Tuesday evening. In addition to these 9 bins, the tenants that live on the corner property (Winter and "D" street corner) also place their bins on Winter street for pick-up. That is a total 12 bins that occupy the area of the proposed 60 foot "No Parking zone. If those bins have to be placed north of this zone, then not only will the 60 foot zone eliminate 2 or more parking spaces, there will be a loss of another 2 or more parking spaces on Monday and Tuesday when the recycling bins are on the street for pick-up. The loss of these parking spaces not only directly impact our tenants, but guests and service vehicles.

The decision to implement the 60 foot "No Parking" zone in front of our properties will significantly and adversely impact the lives of our tenants, as well as an adverse financial impact on the values of our properties.

Please provide me adequate and timely written notice to our mailing address of any and all public hearings or testimony that we may attend concerning the decision making process about this proposal.
