5. Please describe your background and experience as it relates to city affairs. Please be specific if your experience relates to any volunteer or paid positions which interface with a city government.

For the past four years I have managed the Water Resources Development Program in the Oregon Water Resources Department. My team and I work with cities, counties, businesses, non-profits, individuals, legislators, other state and federal agencies, the Water Resources Commission, and various individuals to meet their instream and out-of-stream water needs. We partner with communities on long-term collaborative water planning as well as provide grants and loans to various water supply studies and projects. Cities are one of the many partners I work with day-to-day.

Specifically with the City of Salem, I worked through the City's Conditional Use Permit process as the Chair of my church's leadership team.

I am happy to provide a copy of my resume with a more robust description of my experience in various levels of government over the past 15 years.

6. City Councilors have many responsibilities and serve in a volunteer capacity. Please discuss your availability and commitment to meet the needs of the community in this role. How much time do you have to give?

I have the time necessary to be an active City Councilor. In addition to City Council meetings, work sessions, and neighborhood association meetings, I think it is also important for City Councilors to engage in other community events. My primary commitments at this time are my husband (an instructional assistant at Schirle), my full-time job, and my church leadership team. If nominated and affirmed as a City Councilor I would step down from my church leadership role to ensure I had enough time to meet the necessary commitments and obligations as a City Councilor. I estimate that I could give 8-10 hours a week to the position.

7. Describe your interest in the role. What would you look forward to?

If nominated and confirmed as a city councilor I would look forward to working with my colleagues, city staff, and the residents and businesses of Salem to work through the complex challenges Salem faces as a city. I firmly believe that all of those voices and views are necessary for a thriving Salem. I look forward to listening to all those voices, asking questions, and weighing the pros and cons of the various decisions presented to the City Council.

I enjoy and have made a career out of pursuing collaborative solutions to water governance challenges and would love to apply that skillset to the myriad of challenges the City of Salem faces. I am experienced in working on contentious issues, with stakeholders who have differing, often conflicting views with one another. I am a trained and skilled mediator and facilitator look forward to bringing those skills to the difficult conversations and decisions the City Council must have and make. Many of those decisions are difficult and require careful thought and consideration of city residents, businesses, and visitors. I look forward to the work of understanding the various views and working with all invested in the outcomes.

8. What do you think are some of the most important issues facing the city today? What are your views on those issues?

The City of Salem is facing many pressing issues. A couple that emerge as the most important are: 1) the city budget shortfall and 2) affordable housing. I am pleased to see that the City Council has made progress in considering the various options presented by the task force and explored by City staff. I think it is important for the City to address the shortfall to continue providing necessary City services. As a City Councilor I would work with others to find an option that fills the budget hole in a way that is equitable and transparent. I was one of the few Salem residents that attended a summer work session on the shortfall. When I asked my coworkers and friends if they were aware of the issue, none were. I was very impressed with the City Council's discussion but found the lack of public engagement disappointing. I personally believe that it is important for city residents to be informed of and invested in the solution pursued by the City. I think further engagement of City residents and businesses is necessary, particularly if the City refers the payroll tax option to the voters in May 2020 as intended. I would like to work with the other Councilors and City staff to help the citizens of Salem understand the budget shortfall and options the City has so they can make informed decisions.

Housing issues, such as affordable housing and homelessness, are extremely complex. My view on this issue is that it is important for the City to partner with its citizens, the county, the state, the federal government, non-profits, and businesses to pool resources and ideas. The City must be a leader, doing what it can to ensure affordable housing exists and reduce homelessness, but cannot solve the problems on its own.
