Hello, my name is Thuy-Tien Nguyen, and I would like to state my full support of agenda items 5.a. through 5.e. I have spent most of my life here in Salem, and as an Asian American I can say that I have lived rather comfortably despite being part of the smaller percentage of minorities that are represented in this city. I believe that the "model minority" characterization of people like me has inflicted damage on those that are Hispanic and African American by insinuating the stereotypes of these groups of people, and this has contributed to the disproportionate policing that has been targeted at those who are non-caucasian. Because of this, I have not had any encounters with the police in the same way that my Hispanic friends have unfortunately experienced, and it infuriates me that this sort of racial profiling is condoned. These past several weeks have brought to light the disturbing tolerance of police brutality and injustice within our systems, and the willingness to ignore these realities must stop now. It will take all of us to prevent further abuse of this power, but it will need to start with the actions and initiatives of this council. You must stop providing large amounts of funding to the Salem Police Department, and allocate the budget to focus on schooling, healthcare, homelessness, and other social services. The dominance and authority of the police have for far too long been left unchecked, and this lack of supervision and accountability has only elevated their position of power. With that being said, I also would like to mention the presence of school resource officers in schools. As a recent high school graduate, I can say that having SRO's situated in front of my school or walking throughout the halls has always made me feel uncomfortable and intimidated. I believe that having SRO's on school campuses actually causes more harm than good, and it introduces students to law enforcement far too early in life, especially in an educational setting. By having them on campus, this creates a school to prison pipeline that puts vulnerable students at risk of being locked up in prison in the future. A school should be a place that breeds educated and insightful young adults, NOT prison inmates. I urge you to reconsider the impact your decisions will have on this community and the future of its inhabitants. We want change, and we want it now. Thank you for your time.

I'm not suggesting that SRO's are racist, but the fact that police unions and associations support the re-election of Donald Trump forces us to wonder how they can be anti-racist when they support a racist, white supremacist president.

We've never had a school shooting in Salem schools, but we do have students committing suicide every year. School counselors and psychologists are in a better position than police officers to keep these children alive.

In order to address the school to prison pipeline we need to address the root causes of student behavioral problems, and that has not traditionally been the role of the SRO.

In addition to hiring counselors instead of SROs, some districts have chosen to commit resources to restorative justice programs and the offering of ethnic studies classes.

In spite of being the most multicultural school district in the state, it has been years since any ethnic studies classes have been offered in Salem-Keizer schools.

Nationwide, the vast majority, if not all districts of our size offer ethnic studies classes. In Portland, for example, every high school offers several ethnic studies classes such as African American history, Latino Literature, Chicano Culture, etc....

In Salem Kiezer, the majority of our students and families are of color, but the district has ignored their requests to be able to learn about the history and culture of their people.

Why does our district refuse to offer ethnic studies classes? If using the equity lens when designing curriculum would it not be incumbent upon the district to offer such classes?

Research indicates incontrovertibly that ethnic studies classes have a powerful impact on reducing the school to prison pipeline.

This is not a time for platitudes; the overwhelmingly white leadership in our district has an obligation to make substantive changes and respond to the wishes of our community leaders of color. End the SRO program and allow student to learn about their history and culture.

City Council Members,

My name is Aiyla Thomas and I've lived in Salem with my husband for the past 6 years. After moving here from California and having worked in the education system there for 3 years, I worked for the Salem-Keizer School District for 2 years. I quit due to lack of resources, and safety in Special-Ed classrooms for staff and all students school wide. (The safety in Special-Ed classrooms I'm referring to has nothing to do with police presence).

I am calling for the defunding of the Salem Police department and demanding that their new budget be reallocated. There are many other areas in our city that need funding and the police almost always receive the most or more than necessary.

I am asking that you reallocate the Salem PD's funding and invest it into any and all areas listed below:

- Any funding possible into our local education system and Youth programs! (Oregon as a whole has one of the worst education systems in the country and I've witnessed it first hand as an employee. As of 2018 we lead the nation in the highest rate of homeless youth. Police officers also should not be on campuses anywhere as they offer little to no safety and make many BIPOC students feel unsafe.)
- Healthcare
- Mental healthcare and social workers as first responders to help keep the community safe
- Food Security
- Better public transportation (busses to run later, to all areas of the city, 7 days a week)
- Housing
- Homeless housing and resources

I am also asking that our city:

- Discontinue any general funds or funding from taxpayers that would pay for settlements due to police murders, misconduct, and negligence.
 - Terminate the contract with Salem PD and Salem-Keizer School District. Many BIPOC students do not feel safe around police, nor does their presence on campuses increase safety.
- Personal story- When I switched from being in the classroom full time to subbing, I was at an elementary school that had an event in the library for students that had earned the opportunity to participate. A campus police officer shared about his job and also had a q&a time. At one point this officer started badmouthing firefighters. He said that firefighters don't do much and don't have dangerous jobs, unlike police officers who put their lives on the line daily and drive around looking for bad guys. He literally said to at least 100+ kids that

Firefighters just sit around! What kind of b.s. is that?! Who hires these goons?! He went on to say more nonsense and make himself look like an idiot to adults, but I can't say he didn't leave an impression on the children. How disrespectful of him to be spreading misinformation like that to impressionable students. I DO NOT want my tax dollars going to this nonsense! Police have no business on campuses unless called for an emergency they are trained to handle, which in most cases they aren't when it comes to students misbehaving! A huge portion of teachers can't even handle it so why should we trust police to be able to do something they know nothing about. 5.d. 20-251 I support implementing 8 Can't Wait immediately. This would be a great start, but we must continue working to reduce entry points into the criminal justice system.

5.e. 20-252 I support all efforts to evaluate and remove police officers from SKPS. Funding should re-direct to un-armed social workers.

Below is a public comment related to items 5a through 5e on the City Council's agenda for June 22.

Mayor Bennett and City Councilors,

My name is Sarah Evans, and I live in the Northeast Neighbors neighborhood. I have two children who attend Englewood Elementary School. I am submitting these comments in support of items 5a through 5e on your agenda tonight.

George Floyd, Breonna Taylor, Ahmaud Arbery, Michael Brown, Tamir Rice, Eric Garner, and so many other Black people have died at the hands of police officers who were unable to see and treat them as humans worthy of respect. For way too long, police have used their positions of power and authority to harass, hurt, and even kill Black and brown people for little to no reason. The items on your agenda related to Salem police are incredibly important so that our city starts to take action to dismantle the racism that police departments are built upon.

I would like to focus in particular on items 5a and 5e, related to school resource officers.

Recently, the Portland Public Schools superintendent made the brave decision to remove armed police officers from their schools. I urge you to do the same for Salem schools.

There are many studies that show police officers in schools actually make them less safe, particularly for students of color. When students are arrested, expelled, or otherwise disciplined by police, not only do they miss school time, they frequently stop coming to school because it is not a place where they feel safe or welcome. They are also not getting the real help they need to deal with the issues leading to their misbehavior, issues that would be better met by social workers or counselors rather than police.

Research shows that restorative justice practices, instead of punitive police actions, are much more effective for working with students who are causing disciplinary issues. When students sit down and face the issue directly, hear from the people they affected, and work together with their teachers and peers to come up with ways to make reparations for the harm they caused, they are much more impacted and much less likely to cause problems in the future. They also feel like their school cares about them.

My two sons are currently at Englewood Elementary School. They have had their share of disciplinary issues due to their struggles with ADHD and mental health issues. But they are white, as am I, and I fully recognize that our family will be treated much differently in the long run than if we were black or brown. I fear for their black or brown peers and what will happen to them when they are older and start to be seen as a problem that needs to be removed by police.

I listened to student after student testify at the last Salem-Keizer School Board meeting about the discrimination they had faced from local police, and the fear they felt. It was heart-breaking. Please remove the police from our schools to help our students of color feel safer and like they belong.

I am submitting my comments to be considered before the vote on June 22, 2020. I would like to urge you to vote in support of the following:

1. Reconsidering contracts with Police in our schools.
2. Reallocating Police funds to other areas that can better handle the issues.

The proposed \$64 million to be allocated to law enforcement is not an appropriate amount and must be put toward improving the city rather than supporting an institution that encourages violence, perpetuates the disenfranchisement of Black/Indigenous People of Color (BIPOC), and has clearly demonstrated favoritism toward known hate groups. Police presence in school turns small conflicts between students into life-ruining processes that feed the engorged pipeline of youths, many of whom are BIPOC, into the prison system at early ages, which helps perpetuate the cycles of imprisonment and learned helplessness. Taking cops out of schools will save whole generations of families.

The SPD are not who I want to call about any issues regarding mental health, domestic abuse, sex crimes, hate crimes, or homelessness. I do not trust them to use good judgment, as they have shown bias and are quick to use force. Their performance must be evaluated based on information from a diverse sampling of Salem residents, body cam footage, and other hard evidence. Adopting the policies of 8 Can't Wait is an excellent start to enact immediate progress.

I urge you not to vote in this astoundingly unbalanced budget, and instead consider where funds might be better spent to create an actual safety net for the people of Salem by providing services for homeless people, public services and resources especially for marginalized individuals, and support for survivors of domestic abuse. I hope that you take the time to consider these and other comments before Monday's vote.

Hello,

I am submitting my comments to be considered before the vote on June 22, 2020. I would like to urge you to vote in support of the following:

1. Reconsidering contracts with Police in our schools.
2. Reallocating Police funds to other areas that can better handle the issues.
3. Performance audit for Salem PD.
4. Implementing all 8 Can't Wait policies. <https://8cantwait.org/>
5. Formation of community commission to discuss policing in our schools.

The proposed \$64 million to be allocated to law enforcement is not an appropriate amount and must be put toward improving the city rather than supporting an institution that encourages violence, perpetuates the disenfranchisement of Black/Indigenous People of Color (BIPOC), and has clearly demonstrated favoritism toward known hate groups. Police presence in school turns small conflicts between students into life-ruining processes that feed the engorged pipeline of youths, many of whom are BIPOC, into the prison system at early ages, which helps perpetuate the cycles of imprisonment and learned helplessness. Taking cops out of schools will save whole generations of families.

The SPD are not who I want to call about any issues regarding mental health, domestic abuse, sex crimes, hate crimes, or houselessness. I do not trust them to use good judgment, as they have shown bias and are quick to use force. Their performance must be evaluated based on information from a diverse sampling of Salem residents, body cam footage, and other hard evidence. Adopting the policies of 8 Can't Wait is an excellent start to enact immediate progress.

It is my understanding that Vanessa Nordyke and possibly other councillors will be proposing Salem adopt the CAHOOTS system that Eugene currently uses to dispatch non-police officials to emergency or check-up situations as needed. I hope the Council will consider this carefully because Salem needs a system like this.

I urge you not to vote in this astoundingly unbalanced budget, and instead consider where funds might be better spent to create an actual safety net for the people of Salem by providing services for houseless people, public services and resources especially for marginalized individuals, and support for survivors of domestic abuse. I hope that you take the time to consider these and other comments before Monday's vote.
