

AN ORDINANCE RATIFYING THE CREATION OF AN INTERGOVERNMENTAL ENTITY.

Section 1. Findings.

(b) This ordinance is intended to satisfy the requirements of ORS 190.085, which requires that parties to an agreement forming a new intergovernmental entity enact ordinances ratifying the creation of the entity.

Section 3. Effective Date of Agreement. The effective date of the agreement to form the entity is August 13, 2020.

(a) To serve as the legal entity to support the Alliance, a CoC that promotes communitywide commitment to the goal of preventing and ending homelessness; provides funding for efforts by nonprofit providers and state, tribal, and local governments to quickly rehouse homeless individuals, including unaccompanied youth and families, while minimizing the trauma and dislocation caused to homeless individuals, families, and communities by homelessness; promotes access to and effective utilization of mainstream housing and homeless service programs by homeless individuals; optimizes self-sufficiency among individuals and families experiencing homelessness; and encourages cooperation and coordination among the government, nonprofit, and private providers of services to homeless individuals, including children and youth.

(b) To assure, through cooperation and pooling of common resources, maximum efficiency and economy in governmental operations will provide every resident with the utmost value for every tax dollar.

(c) To attain the greatest degree of intergovernmental cooperation possible in the Mid-Willamette Valley to address the problems experienced by people who are homeless.

1 **Section 5. Function and powers of the ORS 190 Entity.**

2 (a) **Function.** The ORS 190 Entity's primary function is to serve as the Collaborative
3 Applicant to the Alliance and support administration of the Alliance as set forth in 24
4 CRF Part 578, and detailed in the Alliance's governance charter.

5 (b) **Powers.** The ORS 190 Entity shall have the power to:

- 6 (1) Enter into agreements with the United States of America, State of Oregon, or any
7 subdivision or agency or any municipal corporation for the purpose of obtaining
8 financial aid or other participation in attaining the objectives and purposes of the
9 Alliance.
10 (2) To enter into contracts for the provisions of goods and services for terms not to
11 exceed five years to effectuate the functions of the ORS 190 Entity, including the
12 provisions of financial, purchasing, personnel, legal and other administrative services
13 to the Alliance. Notwithstanding the foregoing, the ORS 190 Entity may enter into
14 real property lease agreements for terms not exceeding 20 years.
15 (3) Establish an office and sub-offices, as directed by the member governments.
16 (4) Approve an annual budget for the ORS 190 Entity.
17 (5) Appoint or contract with staff and assign duties, responsibilities and authorities.
18 (6) Exercise any and all powers and functions authorized by law for an intergovernmental
19 entity, including the powers conferred by ORS 190.080, necessary to effectuate the
20 decisions of the Alliance Board of Directors.

21 **Section 6. Severability.** Each section of this ordinance, and any part thereof, is severable, and if
22 any part of this ordinance is held invalid by a court of competent jurisdiction, the remainder of
this ordinance shall remain in full force and effect.
