As a tool to enhance the experience and use of alleys, a pilor lighting project was installed in 2020. The lights to illuminate the alley were changed from armetuers on metal archways attached to private property with easements, to string lights on poles within alley public right-of-way. Union Street Bike Friendly Phase B	One of the projects identified in the Strategic Action Plan was the creation of a Downtown Circulator / Mobility Study. In 2013-14 RDURA funds were allocated for installation of a signal at Commercial Street / Union to provide a tool for bicycles to cross Commercial Street safely. Eastbound cyclists were able to use the signal to allow them to continue straight through the intersection.
