Exhibit "G" Phasing of Work and Transition of Responsibilities

WHEREAS the City of Salem ("City") and the Rotary Club of Salem ("Rotary")—collectively referred herein as "Parties"—entered into a Lease Agreement ("Agreement") effective June 13, 2019 for the construction of the Gerry Frank | Salem Rotary Amphitheater; and

WHEREAS construction of the new facility is well underway at Riverfront Park with the Parties working together in close collaboration on the project; and

WHEREAS the City's General Contractor, Emery and Sons Construction, has substantially completed the City's responsibilities under the agreement as outlined in Exhibit "C" subsection 1.b of the agreement to prepare the site for construction of the covered performance facility; and

WHEREAS construction responsibilities are shifting to Rotary's General Contractor, Dalke Construction, Inc., to build the covered performance facility on the site; and

WHEREAS the parties have acknowledged that it is in the best interest of the City and Rotary that some items be constructed on behalf of the City by Rotary's General Contractor and some items to be constructed on behalf of Rotary by the City's General Contractor.

The Parties therefore agree as follows:

- 1. The City will pay Rotary for the cost to Rotary's General Contractor for constructing the items identified in Attachment 1 to this Exhibit, generally related to irrigation, storm drainage, and landscaping, and relocation of lighting controls.
- 2. Rotary will pay the City for the cost to the City's General Contractor for constructing the items identified in Attachment 1 to this Exhibit, generally related to additional fencing.
- 3. The net reimbursement will be paid by the City to Rotary based on actual costs, currently estimated at \$134,724.
- 4. This document will become part of the Agreement as Exhibit "G" and effective on the date last signed by both Parties.

Counterparts. This Exhibit G may be executed in one or more counterparts, including facsimile or electronic counterparts, and all so executed shall constitute one agreement, binding on all the parties hereto, even though all parties are not signatories to the original or the same counterpart. Any counterpart of this Agreement that has attached to it separate signature pages, which altogether contain the signatures of all parties, shall for all purposes be deemed a fully executed instrument.
