I have enjoyed the living in this area - great parks, safe neighborhood, quiet and peaceful neighbors. This all would change if the proposed plan of connecting this two neighborhoods. I am not in favor of this proposed plan for the following reasons.

First, according to the map a pathway would be constructed through Pioneer Alley neighborhood allowing pedestrians to access our commons space everyday at all times of the day. This would make a safe neighborhood unsafe.

Second, access to this area will have an environmental impact. Since grading will need to be address to due the elevation difference, the current drainage system would not be able to adequately accommodate excess water run-off. Thus resulting in flooding of my neighborhood.
