2	AN ORDINANCE RELATING TO STORMWATER AND FLOODPLAIN OVERLAY ZONE;
2	AMENDING SRC 601.075
3	The City of Salem ordains as follows:
4	Section 1. SRC section 601.075 is hereby amended as set forth in Exhibit A, attached hereto and
5	by this reference incorporated herein.
6	Section 2. Findings. SRC 110.085 establishes the following approval criteria that must be met for a code amendment to be approved:
7	1. The amendment is in the best interest of the public health, safety, and welfare of the City.
8	Finding: The code amendment is in the best interest of the public health, safety, and welfare of the City because it reduces risks of flood damage for flood-prone properties.
9 10	2. The amendment conforms with the Salem Area Comprehensive Plan, applicable Statewide Planning Goals, and applicable administrative rules adopted by the Department of Land Conservation and Development.
11 12	Finding: The Salem Area Comprehensive Plan (SACP) is the long-range plan for guiding development in the Salem urban area. The overall goal of the plan is to accommodate development in a timely, orderly, and efficient arrangement of land uses and public facilities and services that meet the needs of present and future residents of the Salem urban area.
13 14 15	The proposed code amendment was reviewed for conformance with the applicable goals and policies of the SACP, Statewide Planning Goals and administrative rules adopted by the Department of Land Conservation and Development. The following goals and policies relate to the proposed code amendment:
16	• <u>Natural Resources Goal</u> : To conserve open space, protect natural, historic, cultural and scenic resources, and to protect life and property from natural disasters and hazards.
17	<u>Policy 7: Flood Hazards</u> Development in the floodplain shall be regulated to preserve and maintain the capability
18	of the floodplain to convey the flood water discharges and to minimize danger to life and property.
19 20	The proposed code amendment is consistent with the above SACP natural resources goal and policy because it minimizes danger to life and property by reducing risks of flood damage for flood-prone properties.
21 22	• <u>Statewide Land Use Planning Goal 7 – Areas Subject to Natural Disasters and</u> <u>Hazards</u> : Goal 7(C)(7) Local governments will be deemed to comply with Goal 7 for coastal and riverine flood hazards by adopting and implementing local floodplain regulations that meet the minimum National Flood Insurance Program (NFIP)

2	The proposed code amendment conforms to this goal because it implements NFIP requirements established by FEMA for Salem to improve its Community Rating System
3	classification and reduce flood insurance premiums.
4	Section 3. Codification. In preparing this ordinance for publication and distribution, the
5	City Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but
6	(a) Renumber sections and parts of sections of the ordinance;
7	(b) Rearrange sections;
8	(c) Change reference numbers to agree with renumbered chapters, sections or other
	parts;
9	(d) Delete references to repealed sections;
10	(e) Substitute the proper subsection, section or chapter, or other division numbers;
11	(f) Change capitalization and spelling for the purpose of uniformity;
10	(g) Add headings for purposes of grouping like sections together for ease of
12	reference; and
13	(h) Correct manifest clerical, grammatical or typographical errors.Section 4. Severability. Each section of this ordinance, and any part thereof, is
14	severable, and if any part of this ordinance is held invalid by a court of competent
15	jurisdiction, the remainder of this ordinance shall remain in full force and effect.
