## END NOTES TO CHANGE ORDERS:

**1. Change Order No. 2 adds \$45,159.24:** Provides for additional ADA access control systems and increased security for the parking garage.

**2.** Change Order Nos. 1 and 2 add \$59,995: Provides for a re-route of electrical and ethernet conduits and high pressure air lines as a result of a discovered leak on the 60-inch trickling filter effluent line.

**3. Change Order No. 8 adds \$27,000:** Provides for the removal and decommission of the City's old radio system equipment now that all City Departments have been cutover to the new system.

**4. Change Order No. 1 adds \$32,777:** Provides for an increase in the amount of effort required for monitoring during trench excavation for project improvements.

**5.** Change Order No. 2 adds **\$50,000**: Provides for additional window washing and pressure washing throughout City owned buildings.

**6.** Change Order No. 1 adds **\$90,000**: Provides for the increase in patron demand for eContent, limitations in ability to process a larger volume of physical materials, and decreased demand for physical materials.

7. Change Order No. 2 adds \$150,000: Provides for clean up after the ice storm.

8. Change Order No. 3 adds \$125,000: Provides for clean up after the ice storm.

9. Change Order No. 2 adds \$100,000: Underestimated annual usage for fiscal year 2020-21.
