Right-of-Way Vacation Description

A tract of land, being a portion of right-of-way, located in the Southwest One-Quarter of Section 23, Township 7 South, Range 3 West, Willamette Meridian, City of Salem, Marion County, Oregon, and being more particularly described as follows:

Commencing at the southwesterly corner of Lot 9, Block 1 of the plat "Parrish's Addition A to the City of Salem", Volume 1, Page 81, Book of Town Plats, also being on the northerly rightof-way line of an 18.00 foot wide alley; thence along said northerly right-of-way line, South 70°40'00" East 1.00 foot to the Point of Beginning; thence continuing along said northerly rightof-way line, South 70°40'00" East 164.00 feet to the southeasterly corner of Lot 11 of said Block 1, also being on the westerly right-of-way line of 12th Street SE (25.00 feet wide); thence along said westerly right-of-way line, North 19°20'00" East 156.00 feet to the northeasterly corner of said Lot 11, also being on the southerly right-of-way line of E Street NE (35.00 feet from centerline); thence along said southerly right-of-way line, South 70°40'00" East 25.00 feet to the easterly right-of-way line of said 12th Street NE, also being the westerly right-of-way line of Union Pacific Railroad (30.00 feet from centerline); thence along said westerly right-of-way line, South 19°20'00" West 350.00 feet to the northerly right-of-way line of D Street NE (27.50 feet from centerline); thence along said northerly right-of-way line, North 70°40'00" West 25.00 feet to the westerly right-of-way line of said 12th Street NE; thence along said westerly right-of-way line, North 19°20'00" East 176.00 feet to the northeasterly corner of Lot 12 of said Block 1, also being on the southerly right-of-way line of said 18.00 foot wide alley; thence along said southerly right-of-way line, North 70°40'00" West 164.00 feet; thence leaving said southerly right-of-way line, North 19°20'00" East 18.00 feet to the Point of Beginning.

The above described tract of land contains 11,702 square feet, more or less.
