## **RESOLUTION NO. 2021-32**

A RESOLUTION RESCINDING RESOLUTION 2021-30 AND MODIFYING THE CITY OF SALEM PARKS, WATER, AND WASTEWATER SYSTEM DEVELOPMENT CHARGE ELIGIBLE PROJECT LISTS

**Whereas**, SRC 41.100-SRC 41.190 authorizes the imposition of transportation and wastewater system development charges (SDCs) to fund capital improvements for the City of Salem transportation and wastewater systems; and

Whereas, City of Salem Resolution No. 2019-7 established SDCs for the City of Salem, adopted eligible project lists (309 Lists) as required by ORS 223.309, and adopted a methodology setting forth the basis for, and amount of, SDCs; and

Whereas, City of Salem Resolution No. 2019-25 modified 309 Lists for Water and Wastewater; and

Whereas, City of Salem Resolution No. 2020-6 modified 309 Lists for Transportation and Wastewater; and

**Whereas**, City of Salem Resolution No. 2021-1 modified 309 Lists for Parks, Transportation, and Wastewater; and

Whereas, pursuant to ORS 223.309, the City of Salem may modify the 309 Lists at any time; and

Whereas, the City of Salem desires to modify the 309 Lists based on current development patterns; and

**Whereas**, the City Council hereby finds the modification to the 309 Lists to be necessary, proper, and authorized by law;

**Whereas**, City Council adopted Resolution No. 2021-30 to modify 309 Lists for Parks, Water, and Wastewater; however, Exhibit 1 to Resolution No. 2021-30 was incorrect.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SALEM, OREGON, RESOLVES AS FOLLOWS:

**Section 1.** Resolution 2021-30 is hereby rescinded.

Section 2. 309 Lists Modified. The Parks 309 List is modified as follows: add Neighborhood Park titled, "Robins Lane;" modify Neighborhood Parks titled, "Langley Rd," "Deer Park Rd," and "Future NP;" modify Community Parks titled, "North Campus" and "Langley;" add Urban Park titled, "Langley Properties;" modify Urban Parks titled, "W. Doaks Ferry" and "Battle Creek Property." The Water 309 List is modified as follows: add Major Facility project titled, "Skyline Reservoir #2;" modify Pipes quantity under "G-0 – Feeder." The Wastewater 309 List is modified as follows: add Treatment project titled, "North Secondary Clarifiers – Willow Lake WPCF;" add Pipes project titled, "Stortz – Main." The 309 List Modifications are depicted on "Exhibit 1" and are incorporated herein by this reference.

**Section 3. Modification of Prior Resolutions.** This resolution modifies Resolution No. 2019-7, Resolution No. 2019-25, Resolution No. 2020-6, and Resolution 2021-1 and except as herein modified, Resolution No. 2019-7, Resolution No. 2019-25, Resolution No. 2020-6, and Resolution 2021-1 remain in full force and effect.
