SUMMARY:

FACTS AND FINDINGS:

North Gateway Redevelopment Advisory Board (NGRAB)

Appoint **Frank Pack** to a term #1 representing a resident expiring on December 31, 2021.

West Gateway Redevelopment Advisory Board (WSRAB)

Appoint **Samantha Ross** to a partial term expiring on June 30, 2019, representing the interest of business owners, property owners, and others with financial and occupational interests in the area.

BACKGROUND:

North Gateway Redevelopment Advisory Board

Urban Renewal Agency Resolution No. 09-6, which ratified the North Gateway Redevelopment Advisory Board, provides that appointments shall be made by the Urban Renewal Agency Board.

West Salem Redevelopment Advisory Board

Urban Renewal Agency Resolution No. 10-4URA, and Resolution 2002-18, which ratified the West Salem Redevelopment Advisory Board, provides that appointments shall be made by the Urban Renewal Agency Board.
