Salem Housing Advisory Committee (four-year terms)

Appoint **Mark Cusick** to a full term expiring on December 31, 2021.

Appoint **Stephen Gay** to a full term expiring December 31, 2021.

Reappoint **Sarah Owens** to a full term expiring on December 31, 2021.
