Proposed Revenue Task Force membership and status update.

SUMMARY:

On November 27, 2023, Salem City Council formed a Revenue Task Force. At their December 11, 2023, City Council approved the Revenue Task Force Charter and discussed membership selection process and timeline. The Board and Commission Appointments Committee of the City Council is recommending a 25-person Task Force roster, with two alternates. Additional information regarding the timeline and key dates will be presented at the City Council meeting.

ISSUE:

Should the City Council approve the slate of candidates for the City of Salem's Revenue Task Force, as recommended by the Board and Commission Appointments Committee?

RECOMMENDATION:

Approve the slate of candidates for the City of Salem's Revenue Task Force, as recommended by the Board and Commission Appointments Committee

FACTS AND FINDINGS:

At their December 11, 2023 meeting, the Salem City Council approved a charter and a budget for a 20 to 30 member Revenue Task Force.

The purpose of the Revenue Task Force is to explore new, additional revenue sources and adjustment to fees to sustain those services that do not have a dedicated revenue stream consistent with the motion adopted by City Council that created this Task Force. The Task Force's work will be carried out in parallel with the work of the Budget Committee and City Council as they consider amendments to the 2024 adopted budget and formulate the proposed 2025 budget based on revised revenue projections.

On January 9, 2024, the Board and Commission Appointments Committee met to consider almost 160 applicants to the Revenue Task Force. The Committee took into consideration nominations, from within the applicant pool, made by the Mayor and Council. The Committee also strived to meet intent of the Task Force Charter, and considered the overall composition of the group for geographic diversity, representation of key stakeholder groups, lived experience, and other demographic characteristics.

Task Force Charter. The Task Force charter states that the Revenue Task Force should be broadly representative of the diversity that makes up our community including residents and business owners from all City wards, with a variety of lived experience, at varied life stages, and of varied ethnicity and backgrounds. Specifically, the group's composition should - at a minimum - include:

- Community members at large: Salem residents or business owners
- Two representatives from each ward, nominated by City Council members, and two at-large representatives nominated by the Mayor. Ward/at-large representation may overlap with other affiliations.
- Chamber of Commerce representative
- Business representative
- Salem 350 representative
- Latino Business Alliance representative
- City employee union representative

Boards and Commission Committee Recommendation. The Committee unanimously recommends the following candidates for the Revenue Task Force. Candidate statements of interest are included in Attachment 1.

We anticipate alternates will receive all Task Force materials, are expected to participate in meetings, and will be eligible for the stipend. If a Task Force member is absent from a meeting, an alternate will be asked to participate in any voting occurring at the Task Force meeting.

A team of staff, Moss Adams, Parachute Strategies, and DHM will support the Task Force with facilitation, community engagement and surveying, revenue analysis, and project management.

Findings from community outreach and engagement will inform Task Force decision making at key milestones. Additional status reports to Council are anticipated on a monthly basis, with a Work Session devoted to the Task Force recommendations on July 15, 2024.
