Center 50+ Advisory Commission

The Center 50+ Advisory Commission serves as an advisory commission to the City Council and Salem Senior Center Staff in matters related to the operations of the Salem Senior Center.

Human Rights Commission

Salem Revised Code Chapter 8 creates the Human Rights Commission (formerly the Human Rights and Relations Advisory Commission), which states that appointments are made by the Mayor.

FACTS AND FINDINGS:

Center 50+ Advisory Commission

Appoint **John Hughes** to a partial term expiring on December 31, 2020.

Appoint **Jon Deming** to a full term expiring on December 31, 2021.

Appoint **Billie Larson** to a full term expiring on December 31, 2021.

(These are for positions "Community Member - Over 50.")

Human Rights Commission

Appoint **Tricarico Schwartz** to a partial term expiring on December 31, 2019.

Appoint **Lowell Alik** to a partial term expiring on December 31, 2019.

Appoint **Wilma Marchbanks** to a partial term expiring on December 31, 2020.
