Airport Advisory Commission

As described in Salem Revised Code Chapter 9, The Airport Advisory Commission (AAC) advises the Council on all airport matters.

Center 50+ Advisory Commission

The Center 50+ Advisory Commission serves as an advisory commission to the City Council and Salem Senior Center Staff in matters related to the operations of the Salem Senior Center.

Historic Landmarks Commission

The Historic Landmarks Commission advises the Council on matters pertaining to historic sites and structures in Salem, administers the Historic Preservation Ordinance, and assists property owners in preservations of such structures.

Human Rights Commission

Salem Revised Code Chapter 8 creates the Human Rights Commission, which states that appointments are made by the Mayor.

Reappoint **Neil Eldon White** to a term #2 with a term expiring on December 31, 2022.

Appoint **Kat Pence** to a term #1 with a term expiring on December 31, 2022.

<u>Center 50+ Advisory Commission (three-year terms)</u>

Reappoint **Sandy Kinney** to a term #2 with a term expiring on December 31, 2022.

Historic Landmarks Commission (three-year terms)

Reappoint **Carroll Cottingham** to a term #1 with a term expiring on December 31, 2022.

Reappoint **Tracy Schwartz** to a term #1 with a term expiring on December 31, 2022.

Reappoint **Patricia Mulvihill** to a term #1 with a term expiring on December 31, 2022.

<u>Human Rights Commission (three-year terms)</u>

Reappoint **Felicia Bechtoldt** to a term #2 expiring on December 31, 2022.

Reappoint **Tricarico Schwartz** to a term #1 expiring on December 31, 2022.

Reappoint **Lowell Alik** to a term #1 expiring on December 31, 2022.

Appoint **David Rheinholdt** to a partial term expiring on December 31, 2021.
