Appoint **Chris Wilhelm** to a term #1 representing a resident living within the West Salem Neighborhood Association boundaries expiring on June 30, 2023.

Appoint **Michael Ryan** to a term #1 representing industrial business within the West Salem Urban Renewal Area expiring on June 30, 2023.
