Dedication of City Owned Properties as Public Right-of-Way Along 27th Avenue SE Between Kuebler Boulevard SE and Boone Road SE.

ISSUE:

Shall the City Council adopt Resolution No. 2021-13 dedicating properties received by the City of Salem along the east and west sides of 27th Avenue SE between Kuebler Boulevard SE and Boone Road SE as public right-of-way?

RECOMMENDATION:

Adopt Resolution No. 2021-13 dedicating properties received by the City of Salem along the east and west sides of 27th Avenue SE between Kuebler Boulevard SE and Boone Road SE as public right-of-way.

SUMMARY:

It is City practice to acquire property or additional right-of-way by Warranty Deed in fee simple ownership. All or a portion of the acquired property is then dedicated as public right-of-way with a resolution adopted by City Council.

The City received properties through the recording of three Warranty Deeds, Reel 4462, Pages 136, 137, and 138, at Marion County. The street improvements are a requirement of the development on Kuebler and 27th Ave. approved by City Council November 9, 2020, with the adoption of Order No. 2020-5.

All of the properties received and described in Resolution No. 2021-13, are ready to be dedicated as public right-of-way with the adoption of Resolution No. 2021-13 by City Council.

FACTS AND FINDINGS:

- 1. The Notice of Final Land Use Decision, SPR-DAP18-15, approved by City Council November 9, 2020, with the adoption of Order No. 2020-5 for the new Costco development, required street improvements along 27th Avenue SE.
- 2. The City received properties on the east and west sides of 27th Avenue SE to support the proposed street improvements.
- 3. The properties were conveyed to the City by recording three Warranty Deeds, Reel 4462, Pages 136, 137, and 138.
- 4. The properties are ready to be dedicated as public right-of-way.
- 5. The dedicated right-of-way will allow for a roundabout to be constructed at the Costco driveway entrance on 27th Avenue SE
