- 1. The tax increment revenue received in FY 2016-17 and budgeted in FY 2017-18.
- The debt service payments made in FY 2016-17 and budgeted in FY 2017-18.
- 3. The amount of debt issued in FY 2016-17 and budgeted in FY 2017-18.
- 4. The amount and purpose of actual expenditures in FY 2016-17 and budgeted expenditures in

5. An analysis of the impact, if any, of the urban renewal plan on the tax collections for FY 2016-17 for all taxing districts included under ORS 457.430.
