FACTS AND FINDINGS:

The annexation request is for an approximate 0.78-acre territory located at 572 Hile Lane NE (Marion County Assessor Map and Tax Lot No. 072W29BC03500). A vicinity map identifying the location of the territory is included as **Attachment 1**. The facts and findings supporting the annexation, minor comprehensive plan map amendment and zone change, and withdrawal from the Marion County Fire District #1 and East Salem Sewer and Drainage District are included in Ordinance Bill No. 1-24 (**Attachment 2**).
